Maryland Green Registry 2015 award winners and results

Maryland Department of the Environment Deputy Secretary Mary Tung recently recognized Maryland Green Registry leadership winners including **Northrop Grumman Electronic Systems, Prince George's Community College, Hord Coplan Macht, MedImmune/ AstraZeneca** and **Honest Tea** at the sixth annual Maryland Green Registry Leadership



Awards in Baltimore. This year, the Registry has partnered with the <u>U.S. Green Building Council, Maryland Chapter</u> on the event.

In addition to the leadership awards, the Registry announced the collective annual environmental results and cost savings as reported by all 450 <u>Maryland Green Registry</u> member organizations over the past year and the total results of the Registry's <u>Compost Challenge</u>.

Sustainability Highlights

- University of Maryland Baltimore Washington **Medical Center** is developing a cogeneration plant on campus. This is an energy source that delivers two forms of energy (electricity and hot/cold water) by burning natural gas. This project, which is anticipated to be completed in May 2016, will create efficient electrical power and will operate using natural gas. The waste heat produced by the plant will be captured and used for heating the medical center, which will reduce emissions and increase overall energy efficiency. The plant will also increase reliability and power quality, offsetting the need for an additional emergency generator ultimately saving capital dollars. - Starting August 3rd, Upper Chesapeake and Harford Memorial will begin composting food and paper items through Veteran Composting. In cafeterias approximately a half pound of food waste is generated per meal tray. Contact Kevin Long at Long-Kevin@aramark.com
- MedStar Franklin Square Medical Center
 implemented a compressive waste segregation
 program inside its operating rooms this spring. As
 ORs are commonly the largest generator of waste
 inside medical facilities, and specifically the largest
 generator of regulated medical waste, this was a

- great area of opportunity. With their sustainability partner, Reduction In Motion, MFSMC educated surgical services and implemented a program to segregate regulated medical waste, regular trash, and recycling throughout OR procedures. The project successfully decreased regulated medical waste inside the hospital's ORs from 78% to 10% as well as increased recycling by 17% in their operating rooms from January to June 2015! - Johns Hopkins Hospital continues to grow its
- Farmers Market; entering the third year with a total of 13 vendors—including four produce stands that offer fresh, healthy, and local produce. As JHH continues their effort to "avoid human harm" they have partnered with the Maryland Farmers Market Association (MDFMA) and are offering Maryland Market Money promotional events throughout the season, such as the "Healthy Habits @ Hopkins" tote give-a-ways that include recipes and cooking supplies. The Maryland Market Money is a program that matches federal nutrition benefits at the market, providing additional funding for our customers to purchase more at the market (and additional sales for our local farmers)! In 2015, JHH has increased distribution of the totes by 23% as compared to 2014! Contac Kelsey Hallowell at Kelsey@reductioninmotion.com

- Both **Sinai and Northwest Hospitals** are implementing a red bag communal collection program with assistance from their sustainability partner, Reduction In Motion. The hospitals collectively removed over 600 red cans throughout non-critical areas and implemented a communal "bag dispenser" program. By empowering their staff, both hospitals continue to reduce overall red bag waste as part of their Freedom to be Green sustainable programs. The hospitals have worked with local groups and Global Links to donate excess trash cans from these patient rooms for reuse! Additionally, as part of a complete renovation in the Bulk Stores Warehouse, **Northwest Hospital** diverted 100% (1,600 lbs) of the metal shelving, braces, and racks to metal recycling!
- The American Heart Association/American Stroke Association (AHA/ASA) began a new program to accelerate prevention and population-based strategies that will reduce chronic disease and health disparities. These efforts will contribute to building a strong base for evidence-based prevention programming across the nation. In Maryland, Danelle Buchman is the regional campaign manager to work specifically with likeminded stakeholders, as well as worksites and healthcare facilities who will work to promote nutrition and access to healthier food and beverages. - Moveable Feast is starting a five-year food planning process aimed at reducing use of processed foods
 and developing sustainable and local food sourcing practices. Moveable Feast is dedicated to providing the
 best quality product by assesing food production from start to finish. This process will involve evaluation of
 space utilization in their facility, food sourcing practices, gardening and gleaning produce, and

- MedStar Montgomery Medical Center held ten sustainability and wellness events this year including Two Employee Health Fairs, Go Red for Women Day, National Nutrition Month, Earth Day, Food Gardening Lunch and Learn, and Buy Local Week. Over 1000 associates and visitors attended the events and over 1000 tomato, herb and lettuce plants were given away to encourage associates and visitors to food garden and make healthier food choices by growing their own vegetables and hers. As part of Buy Local Week, a celebration was held on July 23rd in the cafeteria where participants took a "farm tour" to area farms for local peaches, cheese, watermelon, blueberries, tomatoes, corn, squash, and freshly cut herbs. In addition, as a community benefit project, MedStar Montgomery partnered with Manna Food Center, the primary food bank in Montgomery County, to support their mission to fight hunger. 
