#### SIGN PRACTICE GREENHEALTH'S EPP PLEDGE

Practice Greenhealth is the nation's leading membership organization for companies in health care that have made a commitment to sustainable, environmentally preferable practices. Practice Greenhealth's **Greening the Supply Chain**<sup>®</sup> **Initiative** provides a common set of tools for purchasers, suppliers and manufacturers to ensure that environmentally preferable products are available, cost competitive, of comparable quality, and generate a sector-wide market shift in the direction of sound environmentally preferable purchasing (EPP) practices. A critical element of the Initiative is the release of the **Standardized Environmental Questions for Medical Products** (Version 1.0), which guides the identification, selection and procurement of environmentally preferable medical products.

## WHAT ARE THE STANDARDIZED ENVIRONMENTAL QUESTIONS FOR MEDICAL PRODUCTS?

The Standardized Environmental Questions for Medical Products are a standard set of questions used in the procurement process for medical products to identify supplier practices that promote environmentally preferable products. These have been endorsed and are being used by five GPOs— Amerinet, HealthTrust Purchasing Group, MedAssets, Novation, LLC, and Premier healthcare alliance—in applicable RFPs. Medical products, for the purposes of this questionnaire, are defined as products used to diagnose, treat or care for a patient. This excludes electronic medical products (anything that plugs in or has a battery), as another set of questions will address electronics.

The questions cover key areas of environmental concern in packaging, manufacturing, use and the end-of-life management of medical products.

Take the pledge to support the greening of the health care supply chain as a way to better protect the health of our communities.

- ☑ Obtain management support to sign the Pledge. (*Pledge signers should be supply chain administrators, vice presidents, or directors.*)
- Support the collaborative work of health care organization to standardize key environmental considerations in contracting and to convey our interest and priorities to them.
- Each year, review upcoming medical supply contracts due to expire within our organization and/or with our GPO, and select at least one contract appropriate to evaluate. Identify and assess opportunities to include relevant environmental attributes (e.g., contains recycled content and/or mercury-free) in value analysis, RFP/ RFIs, and decision-making processes.
- Consider the purchase of products and services with environmentally preferable attributes (e.g., recyclable, free of chemicals of concern) for a healthier hospital environment.
- Become familiar with the thirteen environmental attributes in the Standardized Environmental Questions for Medical Products, and consider how they apply to your organization's supply chain process.
- Affiliate our organization with this effort by allowing Practice Greenhealth to include our organization's name as a Pledge signer on resources and the website.
- When applicable, request details how our GPO will support our commitment to environmentally preferable purchasing.
